

By purchasing vendors space, you agree to these terms and conditions. Please make sure you read this section carefully and understand the terms of conditions outlined herein.

**Set-up and tear-down times:**

**Camping vendors:** Set-up Friday, August 17 4pm; Tear-down Sunday August 18 9am-11am

**Day vendors:** Saturday, August 18, 8am; Tear-down Saturday August 18 10pm-11pm

**Show times:** Public hours are Saturday 11:30AM-10:00PM

**Booth Provisions:** Vendors will receive a 10' x 10' space in which to set up with access to water and electrical hookups. Camping vendors also receive a full camping space immediately behind your booth space with water and electrical hookups. **Vendors are responsible for all furnishings, tables and chairs.** Show management reserves the right to change or move booth locations if deemed necessary.

**Booth Sharing Not Allowed:** Booth space is intended only for the use of the purchasing vendor/vendor. Vendors may not sub-lease, gift or offer booth space to other brands. Vendors found sharing booth space will be asked to remove and secondary brands and display only products/services registered by the purchasing vendor.

**Waste Handling:** Vendors are required to keep exhibit space clean. Upon the close of the Fest, vendors are required to gather garbage and recycling and place it in the designated receptacles. Any vendor leaving garbage in their booth space will be fined a \$200 cleaning fee.

**Security And Risk Of Loss:** Although show management will endeavor to provide basic security during the Fest, management is not liable for lost, damaged, or stolen goods equipment, or personal property. Vendors are advised to carry their own property and casualty insurance to cover losses from whatever source.

**Vendor's Financial Responsibility:** Vendor is financially responsible for any damage caused to booths, decorations, Exhibit Hall property and any injuries and damages to third persons or their property that is caused by or originates in vendor's booth or through vendor's action. Third persons include, but are not limited to, business guests, invitees, others in attendance at Expo, other vendors, show staff, and any other persons at the Expo. Vendor shall protect show management from all such claims, defend show management from such claims, and hold show management harmless from all such claims and the expenses thereof including the costs and attorney fees incurred in defending such claims, and shall pay all such claims for which any legal liability is established.

**Comply With Rules:** Vendors will comply with all venue and show rules when and where they apply, and shall, confine activities including sound and odors to vendor's booth and booth's immediate surroundings.

**Burning Prohibited:** Open flame is not allowed during the live Fest hours. Camping vendors may utilize the designated fire pits appropriately.

**Compliance With Laws:** Vendor will abide by all Federal, State, and City laws pertaining to fire, safety, and behavior. Vendors are responsible for meeting all City/State taxation, resale, licensing, and Health Department requirements.

**Behavior:** Vendors agree to conduct themselves in a respectful, cooperative manner appropriate to the integrity of the attendees, fellow vendors, and show management staff.

**Risk Of Loss For Unavoidable Cancellation or Termination:** Vendors bear risk of loss through show cancellation or termination for which show management bears no responsibility. In the event that any outside force, beyond show management's control, cancels the Fest or prevents it from taking place or continuing, such as, but not limited to, acts of God, acts of civil disobedience or terrorism, acts of war or work stoppage, show management reserves the right to retain payments made by the Vendors to defray all show management's expenses and losses.

**Prepayment Of Fees:** Vendor space will only be reserved with payment in full at time of booking.

**All Booth Sales Final:** All booth sales are final and no refunds will be given if the vendor cancels.

**Show Management Decisions Binding:** Any decisions concerning the operation of the Fest, conduct at the booths and in the aisles, including but not limited to appropriateness of dress and behavior, not otherwise covered by these rules is subject to the sole decision of show management.

**Terms Extend To Future Exhibits And Shows:** Those Vendors who may participate in any future show or other Fest: Should you not have signed a subsequent contract for that Fest, you herewith agree to abide by, and be bound by these rules, terms and conditions in your participation in all future shows and Fests of this Sponsor.

**Violation Consequences:** Violation of any of these terms and conditions or rules made by show management in accordance with this contract may subject the Vendor to immediate expulsion from the Fest, and the Vendor's property may immediately be removed at the Vendor's expense, and the Vendor shall forfeit all payments made under the contract all at the sole and exclusive discretion of the sponsor and Vendor shall not be relieved of any other liabilities and responsibilities under the terms and conditions of the contract.
